Certified check or money order in the amount of \$20.00, payable to: "Commonwealth of Pennsylvania"

Copy of government issued photo ID for subject

Legal affidavit or letter of representation (if applicable)

- You will receive your full arrest record via mail from the Central Repository. After receiving your record, you may then follow up with the Clerk of Courts Office in the county where your arrest took place for further instructions on how to proceed with petitioning the court for expungement.
- 4) After the Pennsylvania State Police receive the court order for expungement from the Clerk of Courts signed by a Commonwealth Court Judge, the record will be expunged.
- 5) All expungement petitions are required to be filed with the Clerk of Courts within 60 days of the date on the Access and Review Background Check.
