

RESOLUTION NO. 071212-23

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF BEAVER IN THE COMMONWEALTH OF PENNSYLVANIA, IN ACCORDANCE WITH ORDINANCE NO. 051100-PK, THE BOARD OF COMMISSIONERS HEREBY AUTHORIZES FLINTLOCK HUNTING IN THREE (3) BEAVER COUNTY PARKS: BRADYS RUN PARK, BRUSH CREEK PARK AND OLD ECONOMY PARK, COMMENCING WITH THE 2012/2013 HUNTING SEASON AND CONTINUING EACH YEAR THEREAFTER UNTIL MODIFIED OR DISCONTINUED BY THE BOARD OF COMMISSIONERS IN ACCORDANCE WITH STATE GAME COMMISSION REGULATIONS;

Whereas, it has been recommended by the Beaver County Recreation Advisory Board that flintlock hunting be allowed during the state designated regular flintlock season in the three (3) Beaver County Parks commencing with the 2012/2013 hunting season and continuing each year until modified or discontinued by the Board of Commissioners.

All state hunting regulations will apply to the Flintlock Hunting in Beaver County Parks. Stipulations to the Flintlock Hunting in the Beaver County Parks are:

BRADYS RUN PARK

- A. Hunting areas will be contiguous from:
1. Wildwood Road (SR 04092)
 2. Anchortown Road (SR 04014)

No parking for the purpose of hunting will be permitted on Bradys Run Road or any of the park's shelter areas. No hunting will be permitted in the main use park areas, such as picnic areas, walking trails, etc. Parking is permitted along Wildwood Road, Anchortown Road, Arboretum Road, the Horse Arena, and the Ice Arena/Recreation Facility parking lot. No permanent tree stands are permitted.

BRUSH CREEK PARK

- A. Hunting is permitted during park hours, which is limited by Ordinance. Hunters should take note of these hours.
- B. Hunting areas will be contiguous from:
 - 1. Barrisville Road (T-578)
 - 2. Petrie Road (T-613)

No parking or hunting will be permitted on or from the main park road (through the park). Parking will be permitted in any of the designated parking areas in the park. No permanent tree stands will be permitted.

OLD ECONOMY PARK

- A. Hunting areas will be contiguous from:
 - 1. Legionville Hollow Road
 - 2. Hemmerle Road (LR 04114)

No parking for the purpose of hunting will be permitted on Forcey Drive. No hunting will be permitted near Forcey Drive. No hunting will be permitted in any main park area such as the shelter areas, swimming pool, or main roadways. Parking will be permitted in the swimming pool lot, and at the Parks' Maintenance Facility on Hemmerle Road.

Handicapped hunters with proper state permits will receive special accommodations as necessary. They are advised to contact the Recreation Department for information. All deer kills must be reported to the Department.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioner of the County of Beaver, a fourth class county under the laws of the Commonwealth of Pennsylvania, AND IT IS HEREBY RESOLVED:

- 1. That, the Commissioners of Beaver County, as recommended by the Recreation Advisory Board and the Beaver County Recreation Department authorizes, in accordance with Ordinance NO. 051100-PK, Flintlock Hunting in

the three (3) Beaver County Parks; (1) Bradys Run Park, (2) Brush Creek Park, and (3) Old Economy Park, with the stipulations and regulations set forth herein above.

2. That the Board of Commissioners, for and in behalf of the County of Beaver, is hereby authorized to execute five duplicate counterparts of said Agreement and the Chief Clerk of the County of Beaver is hereby directed to attest the due execution thereof and to affix the Seal of the County of Beaver thereto.

3. That, following the proper execution, attestation and ensembling of said duplicate counterparts of said Agreement, the Chief Clerk of the County of Beaver is hereby directed to cause delivery of the same as follows: The original to the Controller of the County of Beaver; one duplicate to the Beaver County Law Department; one duplicate to the Recreation & Tourism Department; and one duplicate to the Beaver County Conservation District, for proper distribution.
