The following should be returned to my office by mail, or emailed:

1. One completed copy of the "Beaver County Annual Report" with all of your municipality's tonnages reported.
2. One completed 904 Performance Grant and Commercial Establishment Form
Note: Multiple versions have been provided for your convenience. Choose one in the format that works best for your needs and complete the entire form.

Microsoft Word Format- can be printed and filled in by hand. This can be mailed/scanned and emailed back to me.

Microsoft Excel version- is fillable and can be returned via email, or printed and mailed.

Adobe version- This is a fillable form that can be emailed back or printed and mailed.

The information should be as comprehensive as possible, since some of the data may be used to complete the Act 101 Section 904 Performance Grant Application for your municipality.

Recyclable Material Conversion Chart

The following are assumed weight conversions for common recyclables.

Material	Conversion
Antifreeze:	7.2 lbs. per gallon
Car Battery (Lead Acid):	17.8 lbs.
Truck Battery (Lead Acid):	48.7 lbs.
Motorcycle Battery (Lead Acid):	8.7 lbs.
Rubber Tires (Car):	21 lbs. per tire
Rubber Tires (Truck):	70 lbs. per tire
Used Oil:	7.2 lbs. per gallon
Used Oil Filters:	1.2 lbs. each
Glass (Whole Bottle):	1 ton = 2 yds ³
Newsprint (Loose):	1 ton = 3 yds ³
Corrugated Cardboard:	2.5' x 4' x 5' bale = 1,100 lbs.
Plastic Soda Bottles (Whole, Loose):	30 lbs. = 1 yd ³
Plastic Film:	2.5' x 4' x 5' bale = 1,500 lbs.
Solid & Liquid Fats:	55 gallon drum = 412 lbs.
Freezer (White Good):	1 = 250 lbs.
Refrigerator (White Good):	1 = 250 lbs.
Other Appliances (White Good):	1 = 150 lbs.
Leaves:	4 yd ³ = 1 ton
Grass Clippings:	2 yd ³ = 1 ton
Wood Chips:	1 yd ³ = 500 lbs.
