FURTHER, SHOULD YOU FAIL TO APPEAR AT THE TIME OF YOUR DE NOVO HEARING, THE COURT MAY DISMISS THE APPEAL AND ENTER JUDGMENT IN THE COURT OF COMMON PLEAS ON THE JUDGMENT OF THE ISSUING AUTHORITY.
