

NOTICE OF PUBLIC HEARING  
COUNTY OF BEAVER  
FY 2020 – 2024 CONSOLIDATED PLAN AND  
FY 2020 ACTION PLAN FOR HOUSING  
AND COMMUNITY DEVELOPMENT PROGRAMS

In accordance with the Beaver County Citizen Participation Plan, the County will hold a housing and community development needs hearing at the following time:

**Thursday, April 30, 2020 at 2:00 PM**

This meeting will be accessible to the hearing impaired. The purpose of the public needs hearing is to:

1. Obtain the views and comments of individuals and organizations concerning the County's housing and community development needs generally and as a result of the COVID-19 outbreak. The information gathered will help the County determine the use of Community Development Block Grant (CDBG, CDBG-CV) funds, HOME Investment Partnerships (HOME) funds and Hearth Emergency Solutions Grant (HESG, HESG-CV) funds in the preparation of a FY2019 Annual Action Plan Amendment, the County's 5-year FY 2020-2024 Consolidated Plan and the FY2020 Annual Action Plan.
2. Review the County's CDBG, HOME, HESG, HUD Continuum of Care and Fair Housing Programs, including HESG and Community Services Block Grant (CSBG) funds received through the PA Dept. of Community and Economic Development and the PA Dept. of Human Services. The public is invited to comment on program performance and the Citizen Participation process.
3. Summarize the Consolidated Planning process.

Because the meeting will be held via live stream, the public is being asked to email [lsgnore@beavercountypa.gov](mailto:lsgnore@beavercountypa.gov) or send written questions or comments on housing and community development needs to the Community Development Program of Beaver County, 1013 Eighth Avenue, Beaver Falls, PA 15010. Individuals and organizations are also invited to watch the above-noted hearing and offer their questions and comments on the housing and community development needs of the County of Beaver. All comments and questions received by 4:00pm on Wednesday, April 29, 2020 will be read and addressed at the meeting.

The County anticipates the publication of a summary of its proposed FY2020-2024 Consolidated Plan and FY2020 Annual Action Plan on or around June 1, 2020. At that time the proposed plans will be placed on public display for a thirty (30) day period in which the County will continue to consider written comments. Notice of the display date and subsequent public hearings will be properly advertised. The County is expected to submit the adopted plan to the U.S. Department of Housing and Urban Development on or before July 15, 2020.
