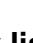

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Crescent Commons (CC) was established as a Permanent Supportive Housing program (PSH pgm) in 2012 to be a bridge to permanent housing for chronically homeless households (CHHH). The CoC felt that a PSH pgm was needed for the hardest-to-place CHHH. CC target populations are CHHH w/ long histories of homelessness & w/ complicated barriers to housing & who have exhausted all other housing options. CHHH who come to CC have little/no income, barriers to housing because of disabilities, & may not be able to obtain public/subsidized housing due to poor tenancy history &/or criminal background. CC offers housing/supportive services to these CHHH & also CHHH headed by unaccompanied youth or sex offenders. Following a Housing First philosophy, adhering to the Equal Access Rule, educating CHHH on the Fair Housing Act, & utilizing the CoC's Coordinated Entry (CE) system, CC seeks to assist/house CHHH that present w/ the greatest need. Veteran CHHH & CHHH with children are prioritized through CE. In 2017-18 CC was designated a Dedicated Plus PSH pgm, broadening its ability to meet the CHHH housing needs. Geographic diversity is central to the selection of housing by CHHH. CC uses the supports provided by McKinney-Vento to expedite school enrollment for the children. Adults w/ children ages 0-5 are given referrals to mainstream resources that provide developmental/educational interventions. VAWA has given CC a valuable tool to assist domestic violence survivor CHHH. CC coordinates w/ our CoC's Supportive Housing Pgms (SHP), our local PHA, ancillary support agencies, & w/ the CE system. It fully participates in the HMIS reporting system. CC has long-standing relationships w/ landlords in our CoC service area. CC is designed to engage fully w/ the CHHH by working w/ a case manager/advocate who has an existing relationship w/ the CHHH. Meeting no less than qtr'ly & often monthly, CC works w/ the CHHH to develop Housing Stability Plans (HSP) that set a course to housing independent of SHP. An assessment is made of the CHHH's strengths/current needs & then sets goals to address those needs. HSP goals may include employment, increased income, & educational goals. Referrals to mainstream resources are given to maximize the likelihood of housing stabilization by broadening the support network around the CHHH. By widening the support options for the CHHH, CC projects positive outcomes which include obtaining/maintaining/increasing income for 90% of the HHs &/or 90% successfully exiting to permanent housing. Continued CoC funding for CC is needed to assure there are housing options for CHHH that have complicated housing barriers & need consistent, on-going assistance to reach independent housing stability. Without the CC pgm, these CHHH would be faced w/ continued homelessness.
