3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This housing-first rapid rehousing (RRH) program works to quickly houses homeless households into permanent housing. Since the program opened on May 1, 2019 The Salvation Army has hired a RRH case manager who is quickly building positive relationships with landlords which has enabled program participants to minimize their length of time homeless and are able to begin working toward their housing stability plan goals. The goals developed will help participants to be self sufficient once rental assistance and case management have ended. During this grant year, this program will house 35 households and 73 participants. Referrals to this program are received from our Coordinated Entry Program and specific populations that are served include households who are chronically homeless, veterans, families involved with our child welfare system, individuals fleeing domestic violence and households struggling with substance abuse and mental health concerns. Participants can receive up to 24 months of rental assistance and case management for up to 6 months after rental assistance ends. Ongoing case management is crucial to this program so participants can be supported as their housing goals are being met. Each participant will complete an initial assessment of strengths and needs, an annual of assessment of strengths and needs, be linked with mainstream and natural supports. County agencies that are commonly coordinated with include the emergency shelters, The Housing Authority of the County of Beaver, The Cornerstone of Beaver County, Beaver County Child Welfare, HHS, and substance abuse and mental health providers. Follow-up case management meetings can also support participants to stay connected to those supports. The Salvation Army anticipates 90%of households will maintain their permanent housing and 85% will increase their income. HMIS will be used to track these measures and by achieving these goals will reduce the number of vulnerabilities that can lead to re-experiencing a homeless episode. COC funding is essential for this program because of our established relationships with COC funded programs and these relationships support The Salvation Army to provide an individualized, tailored case management based on individual client needs.
