

**COUNTY OF BEAVER

PROCEDURES, DISCLOSURES, AND OFFER TO PURCHASE FORM**

The Beaver County Board of Commissioners will accept Proposals for the purchase of a tract of land situated at 1100 6<sup>th</sup> Avenue, Beaver Falls, Beaver County, Pennsylvania. This property encompasses approximately 0.29 acres and is improved with a 1 story vacant office building and paved parking lot.

The parcel is described as Beaver County Tax parcels 03-003-0516.000. The Beaver County Commissioners are offering to sell this parcel, and this property is hereby exposed for public sale. The Beaver County Commissioners will sell this parcel to the person or entity submitting the highest bid following the described procedure:

1. Submit the "Offer to Purchase Form", accompanied by a *Certified or Cashier's Check* in the amount of \$5,000.00, as a refundable *Earnest Payment*, made payable to the "County of Beaver". Submit both the form and payment to the Law Department no later than 4:30 p.m., Monday, June 12, 2017
2. Offers must be equal to or greater than **\$145,000.00**; any offer less than this amount will not be considered.
3. The County will not pay a sales commission, transfer taxes, nor any other fee with respect to this transaction. The buyer is solely responsible for any and all fees, commissions, or transfer taxes. The value noted on the Offer to Purchase must be the net amount to be *received by* the County.
4. The County will determine the successful bidder based solely on the buyers proposed price, and will notify the buyer immediately.
5. The buyer must initiate and conclude, at buyers expense, all due diligence within 60 days of acceptance of the Offer by the County.
6. The County Commissioners will convey the property by special warranty title.
7. By submitting the *Offer to Purchase* and *earnest money*, the buyer agrees to close and tender full payment no later than thirty (30) days after the buyer has completed its period of due diligence. In the event the buyer does not tender full payment and close, absent a showing of extraordinary circumstances which would prevent buyer from closing within this time frame, the earnest money shall be forfeited and the County will award the sale to the next highest buyer.

Interested citizens are welcome to tour the property by making an appointment with the Chief Clerk. To make an appointment by phone, call 724/770-4405 between 8:30-4:30 Monday through Friday, no later than June 12, 2017.

The County reserves the right to reject any and all proposals and to award the sale in the best interest of the County as the Commissioners shall determine. The Commissioners further reserve the right to award the sale to a person unrepresented by an agent. The County makes no representation, and no person claiming to represent the County may likewise make any representation as to the title, lot size, or boundaries, or any structural aspect of said property. All property is sold "As Is." Seller disclosure statements can be made available at the property location and may be reviewed during the tour.
