Safely Home (SH) is a Rapid Rehousing (RRH) program that targets households(HHs) fleeing domestic violence, (DV), dating violence, sexual assault, stalking, &/or victims of human trafficking. SH uses funds to provide medium-term rental assistance, counseling/advocacy & supportive services. The Housing Authority of the County of Beaver (HACB) partnered w/our county's Victim Service Provider, the Women's Center of Beaver County (WCBC), to implement SH; WCBC provides DV eligibility screening as well as case mgmt. & counseling. HACB provides housing search & placement. Both agencies refer to ancillary supportive svcs. such as, but not limited to, moving assistance, childcare & utility deposit assistance. HHs access SH through the CoC Coordinated Entry system. Then a referral to WCBC for eligibility determination & case mgt occurs. Once engaged by SH, staff from HACB/WCBC work w/the HH to identify housing barriers then connect the HH w/resources that strengthen the HH's ability to obtain & maintain permanent housing (PH). SH meets w/clients on an "as needed" basis, no less than monthly. WCBC has a case mgr who engages in safety planning, refers to trauma-informed counseling, educates prospective tenants about VAWA, & can connect w/legal advocacy. Clients are encouraged to keep a relationship w/WCBC to ensure the safety plan is maintained & that HHs can live their life free from abuse. Other than meeting once a month w/ a case manager SH does not have any requirements beyond what a lease would require. SH follows a Housing First philosophy, and HH's are supported regardless of criminal histories, lack of income, disability, or substance abuse. SH adheres to the Equal Access Rule & educates HHs on the Fair Housing Act. SH works w/the CoC to analyze data on Racial Equity quarterly. SH participates w/a lived experience group to assist us annually in reviewing polices & ensures Racial Equity is demonstrated in all CoC programs. SH staff have participated in the HUD 8 wk. workshop on analyzing data and racial equity. HHs have complete control over the selection of housing units. (HH)'s are given referrals to mainstream resources. SH uses supports provided by McKinney-Vento to expedite school enrollment for children. Adults' w/children ages 0-5 are given referrals to resources that provide developmental/educational interventions. SH coordinates w/HACB's voucher programs for housing options & has long-standing relationships w/landlords in our CoC svc area. SH has a MOU w/the county behavioral healthcare provider. WCBC provides furnishings, personal items and access to DV/SA therapy. SH project outcomes are set at: 80% obtaining/maintaining/increasing income, 65% reduction in the rate of return to an abusive situation, & 85% transitioning into PH within 24mos. SH recognizes that HHs fleeing DV (or other related crimes) have unique needs & face many barriers to feeling as though they are "safely home". SH is designed to move HHs rapidly to safety & stability. SH expects to assist 12 HHs/24 people over the term of the grant. It fully participates in the HMIS reporting system. Continued CoC funding for SH is needed to assure there are housing options for survivors of DV that have unique housing barriers & need continuous, ongoing assistance to reach independent housing stability. SH's Rental Assistance & Supportive Svcs answer that need & will be used to move HHs on to self-sufficiency.

Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

- Monitoring and evaluating compliance.
