PUBLIC NOTICE PROPOSED FIVE YEAR CONSOLIDATED PLAN FOR FY 2025-2029 AND FUNDING APPLICATION FOR FY 2025

In accordance with the federal regulations at 24 CFR, Parts 91 et al., the County of Beaver is required to prepare and submit a Consolidated Plan for its Housing and Community Development Programs to the U.S. Department of Housing and Urban Development (HUD). Notice is hereby given by the County of Beaver that a proposed Consolidated Plan has been prepared, and the County intends to apply for \$3,190,637 in federal Community Development Block Grant (CDBG) funds, \$542,349.79 in HOME funds and \$281,941 in Hearth Emergency Solutions (ESG) funds for FY 2025. In addition, the County anticipates the receipt of CDBG program income in the amount of \$80,000. The County intends to use these funds plus available funding from Act 137 Affordable Housing Funds and Regional ESG Funds for Consolidated Plan projects. In order to obtain the views of citizens, public agencies and other interested parties, the County of Beaver has placed its proposed Five Year Consolidated Plan for FY 2025-2029 and proposed use of funds for FY 2025 on display in the following locations during normal operational hours: 1. Community Development Program of Beaver County, 1013 Eighth Avenue, Beaver Falls, PA; 2. Beaver County Commissioners Office, County Courthouse, 810 Third Street, Beaver, PA; 3. Housing Authority of Beaver County, 300 State Street, Vanport, PA; 4. B. F. Jones Memorial Library, 663 Franklin Avenue, Aliquippa, PA; 5. Carnegie Free Library, 1301 Seventh Avenue, Beaver Falls, PA; 6. Carnegie Free Library, 61 Ninth Street, Midland, PA. and on the Beaver County website at www.beavercountypa.gov. The information will be available for review for 30 days beginning June 16, 2025. Public comment on the proposed Consolidated Plan can be directed to the Community Development Program of Beaver County, 1013 Eighth Avenue, Beaver Falls, PA 15010. Public comment must be received no later than July 16, 2025. The Five-Year Consolidated Plan for FY 2025-2029 and the proposed use of funds for FY 2025 contains the following major components:

1. Identification of federal and non-federal resources reasonably expected to be made available during the program year to undertake activities identified in the five-year Consolidated Plan.

2. A list of activities to be undertaken during the program year to address community development and housing needs including the geographic distribution of activities to be completed.
