Please fill out the form completely and obtain the required certification from the Adult Probation Department that you have successfully completed the A.R.D. Program (Accelerated Rehabilitative Disposition). All costs, fines and restitution assessed to your court case must be paid in full. You may utilize the public website for docket number information: https://ujsportal.pacourts.us

The original Motion for Dismissal/Expungement along with the fee of \$132.00 (cash or credit card) must be filed simultaneously at the Clerk of Courts' Office, 810 Third Street, Beaver, PA 15009. The Clerk of Courts will serve a copy of the Motion upon the District Attorney's Office. The District Attorney's Office has 30 days to consent or object to the Expungement. If the District Attorney files his Consent, the motion will be forwarded to the Motion Court Judge for signature. If there is an Objection, most likely a hearing will be requested by the District Attorney.

Once a Order of Court is signed your name will be removed from the state's computer database (CPCMS) after notification to the Administrative Office of Pennsylvania Courts. Certified copies of the Order will be mailed to each of the keepers of record that have a copy of your criminal record. Each of these offices will return an Affidavit of Expungement of compliance to the Clerk's Office indicating they have removed your name from their database and have destroyed the information pertaining to the case. Sometimes it may take several months to retrieve all of the affidavits. Note: The Expungement is not final until we have received all affidavits. Once all copies of each Affidavit are returned to the Clerk of Courts' Office, a Final Certificate (Order), will be mailed to you at your last address of record.

Should you present a Certificate of Attendance from CareerLink, dated within the last two (2) years, or if you are a Veteran and provide a copy of your DD-214 indicating an HONORABLE DISCHARGE, to the Clerk of Courts at the time of filing your Motion, the Court is willing to waive the Expungement filing fee.
