## OBTAINING A DIVORCE IN BEAVER COUNTY 3301(d) – Non-consent Divorce (Separated for 1 year)

- Please follow the instructions in the packet very carefully.
- Divorces are filed in the Prothonotary's Office, located on the first floor of the Beaver County Courthouse.
- At the time of filing, there will be a filing fee, as indicated by Prothonotary.
- If, at any time after the filing of the Divorce Complaint, either party's address changes, that party <u>must</u> notify Prothonotary directly (providing Prothonotary with an envelope with the new address will not qualify), as this is how you are notified if there is an error in your paperwork.
- If you are seeking to have the filing fee waived, complete an In Forma Pauperis, which is a separate form and not part of this packet, and take it to Courtroom #4 no later than 8:45 a.m. any Tuesday or Thursday morning to present to the Judge.
- **Remember** NO courthouse staff may assist in filling out forms. If you have any questions, please consult an attorney.

### HOW TO PROCEED WITH A 3301(d) NON-CONSENT DIVORCE:

The Pennsylvania Rules of Civil Procedure for a 3301(d) divorce require the parties to be separated for **one** (1) **year** before proceeding with a 3301(d) non-consent no-fault divorce.

If you have already been separated for at least one year before you file for divorce, you may begin the divorce process under a Section 3301(d) divorce.

If you have NOT been separated for at least one year before you file for divorce, you may begin the divorce process under a Section 3301(d) divorce by completing STEP ONE and STEP TWO (filing the Complaint). Thereafter, you MUST wait until you have been separated for at least one year to proceed to STEP THREE.

### **►**STEP ONE: Complete and File the Entry of Appearance as a Self-Represented Party (Form 1)

If you are proceeding as a self-represented party, complete and file Form 1 in the Prothonotary's Office. If you change your address anytime thereafter, you **must** notify the Prothonotary.

### **►**STEP TWO: Complete and File the Notice to Defend; and Complaint for Divorce (Form 2)

Complete the entire Form 2. Fill in all blanks.

The caption at the top of each form includes your name, your spouse's name, and the docket number assigned to the case by the Prothonotary's office. This caption <u>MUST</u> be identical on all documents filed in your case, regardless of which party is filing the document.

File Form 2, upon completion, in the Prothonotary's Office. Bring two (2) extra copies. The Prothonotary will time-stamp and keep the original. The two (2) copies will be time-stamped and returned to you. One copy is for your records, and the other copy must be served on your spouse as described in <u>STEP FOUR</u>.

**IF YOU HAVE BEEN SEPARATED FOR AT LEAST ONE (1) YEAR**: Proceed with the following steps.

If you have <u>NOT</u> been separated for at least one year, <u>STOP</u>. You may proceed only AFTER you have been separated for at least one year.

# <u>▶STEP THREE</u>: Complete and File the Affidavit Under 3301(d) of the Divorce Code (Form 3-A); a Blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B); AND the Affidavit of Non-Military Service (if applicable) (Form 7)

You cannot obtain a 3301(d) divorce against an unrepresented Defendant <u>if</u> he/she is in the military. Therefore, <u>if your spouse is not represented by counsel</u>, you must also complete and sign an Affidavit of Non-Military Service (Form 7).

Take the completed and signed original Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), and Affidavit of Non-Military Service (Form 7), if applicable, along with two (2) copies of each to the Prothonotary.

The Prothonotary's Office will time-stamp the originals and the copies of each. The original will stay in the Prothonotary's file, and two (2) copies of each will be returned to you. One of the copies is for your records and the other is to serve upon your spouse as outlined in <u>STEP FOUR</u> below.

<u>Reminder</u>: If you already filed the Complaint (Form 2), then you only need to file the Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A) and Affidavit of Non-Military Service (Form 7), if applicable.

# ►STEP FOUR: Serve the Divorce Complaint (Form 2), Affidavit Under 3301(d) of the Divorce Code (Form 3-A), Blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B), AND Affidavit of Non-Military Service (if applicable) (Form 7)

After filing the Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), and Affidavit of Non-Military Service (Form 7), if applicable, at Prothonotary, you **must serve, BY ORIGINAL PROCESS**, the time-stamped Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, **AND** a blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B) upon your spouse **within thirty (30) days of the date they were filed** (this is the date time-stamped on the documents).

If the other party does not live in Pennsylvania, the time requirement is extended to <u>ninety (90)</u> days.

If service is not completed within 30 days (or 90 days if outside of Pennsylvania) of the date of <u>filing</u>, you must file a Praecipe to Reinstate Complaint (Form 5). The date you file this Praecipe re-starts the clock for service. You will have another 30 days (or 90 days) to serve your spouse.

#### YOU MUST SERVE YOUR SPOUSE IN ACCORDANCE WITH Pa.R.C.P.

**1930.4 IN ORDER TO PROCEED.** According to Pa.R.C.P. 1930.4, service of the Divorce Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, and blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B) must be made upon your spouse in any of the following three ways.

#### **OPTION ONE:** Affidavit of Acceptance of Service (Form 4-A)

Give your spouse the Divorce Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, and a blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B) **and** the Affidavit of Acceptance of Service (Form 4-A). Your spouse MUST print their name, sign, and date the Acceptance of Service stating they have received a copy of Form 2, Form 3-A, and Form 3-B. Your spouse MUST then give it back to you to file with the Prothonotary. Make a photocopy for your records.

#### **OPTION TWO:** Affidavit of Service by Mail (Form 4-B)

Mail the Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, and a blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B) to your spouse by <u>regular mail AND Certified Mail</u>, <u>Restricted Delivery WITH return receipt requested</u> (use US Postal Form 3811 from the post office). The return receipt will be a green card with your spouse's signature and the date he/she signed.

You must then complete the Affidavit of Service by Mail (Form 4-B) stating that you have mailed your spouse the required forms as described above. You <u>MUST</u> attach the green card, which you will receive back from the post office, to the Affidavit of Service by Mail proving your spouse signed for the envelope. File the original Form 4-B with the original green card attached in the Prothonotary. Make a photocopy of this for your records.

\*\*\*If the Certified Mail Restricted Delivery is returned as "unclaimed," another type of service must be used.

#### **OPTION THREE:** Affidavit of Service by Personal Service (Form 4-C)

Any competent adult, <u>other than you</u>, may personally hand the Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, and blank Counter-Affidavit Under 3301(d) of the Divorce Code (Form 3-B) to your spouse.

The third party who hands the documents to your spouse <u>MUST</u> complete, date, and sign the Affidavit of Service by Personal Service (Form 4-C), then they must give it back to you to file the original with the Prothonotary. Make a photocopy for your records.

#### **►STEP FIVE**: Wait 20 days

<u>General Information</u>: The Pennsylvania Rules of Civil Procedure require that twenty (20) days elapse after serving the Complaint, Affidavit, and Counter-Affidavit in a 3301(d) divorce.

If your spouse completes and files the Counter-Affidavit Under 3301(d) of the Divorce Code denying the date of separation or raising claims, either party may present a motion requesting the Court resolve the issue(s).

If your spouse does <u>not</u> oppose the divorce and does <u>not</u> wish to raise additional claims, they do <u>not</u> need to take any action on the Counter-Affidavit Under 3301(d) of the Divorce Code and you may proceed to the next step.

# ►STEP SIX: Complete, File, and Serve the Notice of Intention to File the Praecipe to Transmit the Record Under Section 3301(d) of the Divorce Code (Form 6); Another Blank Counter-Affidavit (Form 3-B); and copy of Praecipe to Transmit Record (Form 9);

After a minimum of twenty (20) days from proper service of the Complaint (Form 2), Affidavit Under Section 3301(d) of the Divorce Code (Form 3-A), Affidavit of Non-Military Service (Form 7), if applicable, and blank Counter-Affidavit Under Section 3301(d) of the Divorce Code (Form 3-B), you must complete, file, and serve your spouse with the following:

- A Notice of Intention to File the Praecipe to Transmit Record Under Section 3301(d) of the Divorce Code (Form 6);
- Another blank Counter-Affidavit (Form 3-B); AND
- A <u>copy</u> of the proposed Praecipe to Transmit Record (see Form 9) that indicates the date and manner of service of the Notice of Intention to File the Praecipe to Transmit Record (the original will be filed in the future).

Complete and sign the Notice of Intention to File the Praecipe to Transmit Record Under Section 3301(d) of the Divorce Code (Form 6), <u>inserting a date that is at least 20 days after your spouse will be served with the form</u>, and the Praecipe to Transmit Record (Form 9). Make two (2) copies.

Take the original and two (2) copies of Form 6 to the Prothonotary. The Prothonotary's Office will time-stamp the original and copies. The original will stay in the Prothonotary's file and the copies will be returned to you; one to serve upon your spouse and one for you to keep for your records.

If there are claims in the Divorce Complaint or Answer to the Complaint for equitable distribution, attorney fees and costs, alimony, etc., they <u>MUST</u> be withdrawn by the party raising them or resolved by agreement of the parties or Order of Court.

Mail copies of Form 6, Form 3-B, and a **copy** of Form 9 by First Class Mail to your spouse.

Complete, date, and sign the Certificate of Service (Form 8) by marking the appropriate boxes for the documents you have mailed to your spouse. Make one copy of Form 8 for your records.

Take the original and one (1) copy of Form 8 to the Prothonotary. The Prothonotary's Office will time-stamp the original and copy. The original will stay in the Prothonotary's file, and the copy will be returned to you for your records.

<u>Note</u>: The parties may alternatively sign and file Waivers of Notice of Intention to File the Praecipe to Trasmit Record (Forms 6-A and 6-B from the 3301(c) packet). The Notice of Intention to File the Praecipe to Transmit Record Under Section 3301(d) of the Divorce Code (Form 5) is <u>NOT</u> required <u>IF</u> the parties choose this alternative. The Waivers of Notice must be filed in the Prothonotary within <u>thirty</u> (30) <u>days</u> of being signed.

### ► STEP SEVEN: Wait an additional 20 days after STEP SIX (second 20-day waiting period)

<u>General Information</u>: The Pennsylvania Rules of Civil Procedure require that twenty (20) days elapse between serving the Notice of Intention to File the Praecipe to Transmit the Record Under Section 3301(d) of the Divorce Code (Form 6) and filing the Praecipe to Transmit Record (Form 9).

#### **► STEP EIGHT**: Practipe to Transmit Record (Form 9)

Complete the Praecipe to Transmit Record (Form 9). Attach a copy of the Notice of Intention to File the Praecipe to Transmit the Record under Section 3301(d) of the Divorce Code (Form 6) and a blank Counter-Affidavit (Form 3-B) to Form 9, which you had previously served on your spouse.

THE PREAECIPE TO TRANSMIT RECORD MUST BE FULLY COMPLETED WITH CORRECT DATES. You will be required to make all corrections on this form before your divorce is finalized. READ THE FOLLOWING STEPS VERY CAREFULLY.

- Paragraph #1: You must select 3301(d) (the divorce you are filing).
- Paragraph #2: Please ensure the date of service and method of service are correct. The date of service will depend on the method of service you utilized in <u>STEP THREE</u> (refer to your copies to ensure the correct date and manner of service).
- Paragraph #3: Please ensure the dates you signed and served the Affidavit are correct.
- Paragraph #4: You MUST report if there are any claims pending. If there are none, say "none." You CANNOT leave this option blank or say it is not applicable.

Paragraph #5: Please ensure the date and method of service of the Notice of Intention to File the Praecipe is correct (or, if Waivers of Notice were filed, the dates for the <u>FILING</u> of the Waivers of Notice).

Be sure to sign and date at the bottom of the page

<u>Reminder</u>: The date of execution is the date the form was signed. The date of filing is the date the form was time-stamped by the Prothonotary's Office.

#### **► STEP NINE**: Divorce Information Sheet (Form 10)

The Divorce Information Sheet (Form 10) must be completed and filed in the Prothonotary's Office.

Here, include the docket number, Plaintiff's name, Defendant's name, date of marriage, and check the appropriate line for the number of years you were married.

#### **►** STEP TEN: Divorce Decree (Form 11)

Submit Form 11 to the Prothonotary with completed Form 9 and Form 10.

If corrections need to be made in the paperwork, a final Divorce Decree will **not** be entered until the Court has the corrected paperwork. The responsibility of submitting accurate paperwork is that of the parties. You will be notified at the address of record in the Prothonotary.

Once a Divorce Decree is signed by the Judge, as long as you have provided the Prothonotary two stamped envelopes, one with your current address and one with your spouse's current address as indicated at Prothonotary, a copy will be mailed to both parties.

\*\*Please ensure the names in the caption and the Divorce Decree itself are identical to how you wrote the names in the Complaint and corresponding Civil Cover Sheet.

\*\*The responsibility of submitting accurate paperwork is that of the parties; the Court will not correct filings with mistakes.

#### LIST OF FORMS FOR 3301(d) DIVORCE

These forms are not designed for complicated divorce issues. It is likely that any complex divorce matter is going to require additional forms that are not included here and the expertise of a lawyer. Examples of a complicated divorce matter include: a request to divide property, receive alimony, payment of attorney's fees and expenses, or if your spouse is in the military.

IF YOU FAIL TO RAISE A CLAIM FOR ALIMONY, DIVISION OF PROPERTY, LAWYER'S FEES OR EXPENSES IN YOUR DIVORCE COMPLAINT, YOU WILL WAIVE OR LOSE THE RIGHT TO MAKE SUCH CLAIMS WHEN THE DIVORCE DECREE IS ENTERED.
