## OBTAINING A DIVORCE IN BEAVER COUNTY 3301(c) – Consent Divorce

- Please follow the instructions in the packet very carefully.
- Divorces are filed in the Prothonotary's Office, located on the first floor of the Beaver County Courthouse.
- At the time of filing, there will be a filing fee, as indicated by Prothonotary.
- If, at any time after the filing of the Divorce Complaint, either party's address changes, that party <u>must</u> notify Prothonotary directly (providing Prothonotary with an envelope with the new address will not qualify).
- If you are seeking to have the filing fee waived, complete an In Forma Pauperis, which is a separate form and not part of this packet, and take it to Courtroom #4 no later than 8:45 a.m. any Tuesday or Thursday morning to present to the Judge.
- **Remember** NO courthouse staff may assist in filling out forms. If you have any questions, please consult an attorney.

#### **HOW TO PROCEED WITH A 3301(c) CONSENT DIVORCE**

A divorce under Section 3301(c) of the Divorce Code is meant for spouses who BOTH consent to a divorce. If your spouse will NOT consent to a divorce, <u>STOP HERE</u> AND IF YOU HAVE BEEN SEPARATED FOR AT LEAST ONE (1) YEAR, YOU MAY PROCEED WITH A DIVORCE UNDER Section 3301(d) of the Divorce Code.

## **STEP ONE:** Complete and File the Entry of Appearance as a Self-Represented Party (Form 1)

If you are proceeding as a self-represented party, complete and file Form 1 in the Prothonotary's Office.

## **STEP TWO:** Complete and File the Notice to Defend; and Complaint for Divorce (Form 2)

Complete the entire Form 2. Fill in all blanks.

The caption at the top of each form includes your name, your spouse's name, and the docket number assigned to the case by the Prothonotary's office. This caption <u>MUST</u> be identical on all documents filed in your case, regardless of which party is filing the document.

File Form 2, upon completion, in the Prothonotary's Office. Bring two (2) extra copies. The Prothonotary will time-stamp and keep the original. The two (2) copies will be returned to you. One copy is for your records, and the other copy must be served on your spouse as described in <u>STEP THREE</u>.

#### **STEP THREE:** Serve Form 2 on Your Spouse

After completing and filing Form 2 as described in <u>STEP TWO</u> above, Form 2 must be served on your spouse within <u>thirty (30) days</u> of the date you filed the documents, which is the date that is time-stamped by the Prothonotary.

If your spouse does not live in Pennsylvania, the time requirement is extended to ninety (90) days.

If you do not properly serve your spouse within 30 days of the date of filing (or 90 days if outside of Pennsylvania), the Complaint (Form 2) must be reinstated using the Praecipe to Reinstate the Complaint (Form 4) and must be re-served.

YOU MUST SERVE YOUR SPOUSE IN ACCORDANCE WITH Pa.R.C.P. 1930.4 IN ORDER TO PROCEED. According to Pa.R.C.P. 1930.4, service of the Notice to Defend; and Complaint for Divorce (Form 2) must be made in any of the following three (3) ways, AFTER they are filed with the Prothonotary's Office.

• **OPTION ONE:** Affidavit of Acceptance of Service (Form 3-A)

Give your spouse Form 2 **and** the Affidavit of Acceptance of Service (Form 3-A). Your spouse <u>MUST</u> print their name, sign, and date the Acceptance of Service stating they have received a copy of Form 2. Your spouse <u>MUST</u> then give it back to you to file in the Prothonotary's Office. Make a photocopy for your records.

• **OPTION TWO:** Affidavit of Service by Mail (Form 3-B)

Mail Form 2 to your spouse by <u>regular mail AND Certified Mail</u>, <u>Restricted Delivery WITH return receipt requested</u> (use US Postal Form 3811 from the post office). The return receipt will be a green card with your spouse's signature and the date he/she signed.

You must then complete the Affidavit of Service by Mail (Form 3-B) stating that you have mailed your spouse the required forms as described above. You <u>MUST</u> attach the green card, which you will receive back from the post office, to the Affidavit of Service by Mail (Form 3-B) proving your spouse signed for the envelope. File the original Form 3-B with the original green card attached in the Prothonotary's Office. Make a photocopy for your records.

\*\*\*If the Certified Mail, Restricted Delivery is returned as "unclaimed," another type of service must be used.

• **OPTION THREE:** Affidavit of Service by Personal Service (Form 3-C)

Any competent adult, <u>other than you</u>, may personally hand Form 2 to your spouse. The third party who hands the documents to your spouse <u>MUST</u> complete, date, and sign the Affidavit of Service by Personal Service (Form 3-C), then they must give it back to you to file the original in the Prothonotary's Office. Make a photocopy for your records.

## STEP FOUR: Wait ninety (90) Days from the Date the Complaint (Form 2) was SERVED.

Once you have completed proper service on your spouse as described in <u>STEP THREE</u>, the Pennsylvania Rules of Civil Procedure require both parties to wait <u>ninety (90) days</u> from the <u>date</u> <u>of SERVICE or receipt</u> of the Complaint (Form 2) before signing/filing the consent forms in STEP FIVE below.

**<u>DO NOT</u>** complete, sign, or file any other forms aside from those in <u>STEP ONE</u>, <u>STEP TWO</u>, and <u>STEP THREE</u> in this packet BEFORE 90 days have passed from the date of SERVICE of the Complaint.

## **STEP FIVE:** Complete and File the Affidavits of Consent (Forms 5-A and 5-B) AND Waivers of Notice (Forms 6-A & 6-B)

**1. Affidavit of Consent**: After the 90-day waiting period, each party must sign, date, and file an Affidavit of Consent (Forms 5-A and 5-B) declaring that they consent to the divorce.

Both parties' Affidavit of Consent must be filed in the Prothonotary's Office within thirty (30) days of the date it is signed and dated. If you do not follow this step correctly, the Affidavit of Consent must be re-signed and re-filed.

Please ensure the date in Paragraph #1 on this form is correct – input the date the Complaint was filed in the Prothonotary's Office, which is the time-stamped date by the Prothonotary. If you input the wrong date, your divorce cannot be finalized and you will be required to file a new Affidavit of Consent.

**2. Waiver of Notice:** After the 90-day waiting period, each party must sign, date, and file a Waiver of Notice (Forms 6-A and 6-B) in addition to signing and filing an Affidavit of Consent.

Both parties' Waivers of Notice must be filed in the Prothonotary's Office within thirty (30) days of the date it is signed and dated. If you do not follow this step correctly, the Waiver of Notice must be re-signed and re-filed.

Please ensure you are selecting an option for Paragraph #1 on this form. If you do not select an option, your divorce cannot be finalized and you will be required to file a new Waiver of Notice.

If both parties sign/file a Waiver of Notice, either party may proceed to <u>STEP SIX</u>.

<u>ALTERNATIVELY</u>, if Waivers of Notice are not signed and filed, either party can mail the other party a Notice of Intention to File the Praecipe to Transmit the Record under Section 3301(c)(1) of the Divorce Code (Form 7):

One party will mail the other party a Notice of Intention to File the Praecipe to Transmit the Record under Section 3301(c)(1) of the Divorce Code <u>AND</u> Counter-Affidavit (Form 7). The Certificate of Service (Form 8) must then be completed, signed, and filed in the Prothonotary's Office. Twenty (20) days from the date Form 7 was mailed to the other party must pass before you may file the Praecipe to Transmit Record (Form 9).

#### **STEP SIX:** Complete and File Praecipe to Transmit Record (Form 9)

Upon the filing of both parties' Affidavits of Consent (Forms 5-A & 5-B) and Waivers of Notice (Forms 6-A & 6-B), the divorce may be concluded by either party filing a completed, signed, and dated Praecipe to Transmit Record (Form 9) in the Prothonotary's Office.

THE PREAECIPE TO TRANSMIT RECORD MUST BE FULLY COMPLETED WITH CORRECT DATES. You will be required to make all corrections on this form before your divorce is finalized. READ THE FOLLOWING VERY CAREFULLY.

- Paragraph #1: You must select 3301(c) (the divorce you are filing).
- Paragraph #2: Please ensure the date of service and method of service are correct. The date of service will depend on the method of service you utilized in <u>STEP THREE</u> (refer to your copies to ensure the correct date and manner of service).
- Paragraph #3: Please ensure the dates that each party <u>SIGNED</u> his/her Affidavit of Consent are correct (refer back to your copies of the Affidavit of Consent for the date both parties SIGNED the Affidavit of Consent).
- Paragraph #4: You MUST report if there are any claims pending. If there are none, say "none." You CANNOT leave this option blank or say it is not applicable.
- Paragraph #5: Please ensure the dates for the <u>FILING</u> of the Waivers of Notice, or the service of the Notice of Intention to File the Praecipe, are correct. For Waivers of Notice, this will be the filing date that is time-stamped by the Prothonotary, NOT the date both parties signed.

Be sure to sign and date at the bottom of the page.

## **STEP SEVEN:** Complete and File Divorce Information Sheet (Form 10)

The Divorce Information Sheet (Form 10) must be completed and filed in the Prothonotary's Office.

Here, include the docket number, Plaintiff's name, Defendant's name, date of marriage, and check the appropriate line for the number of years you were married.

#### **STEP EIGHT: Submit Divorce Decree (Form 11)**

Submit Form 11 to the Prothonotary with completed Form 9 and Form 10.

If corrections need to be made in the paperwork, a final Divorce Decree will <u>not</u> be entered until the Court has the corrected paperwork. The responsibility of submitting accurate paperwork is that of the parties.

Once a Divorce Decree is signed by the Judge, as long as you have provided the Prothonotary two stamped envelopes, one with your current address and one with your spouse's current address, a copy will be mailed to both parties.

\*\*Please ensure the names in the caption and the Divorce Decree itself are identical to how you wrote the names in the Complaint and corresponding Civil Cover Sheet.

\*\*The responsibility of submitting accurate paperwork is that of the parties; the Court will not correct filings with mistakes.

#### LIST OF FORMS FOR 3301(c) DIVORCE

These forms are not designed for complicated divorce issues. It is likely that any complex divorce matter is going to require additional forms that are not included here and the expertise of a lawyer. Examples of a complicated divorce matter include: a request to divide property, receive alimony, payment of attorney's fees and expenses, or if your spouse is in the military.

IF YOU FAIL TO RAISE A CLAIM FOR ALIMONY, DIVISION OF PROPERTY, LAWYER'S FEES OR EXPENSES IN YOUR DIVORCE COMPLAINT, YOU WILL WAIVE OR LOSE THE RIGHT TO MAKE SUCH CLAIMS WHEN THE DIVORCE DECREE IS ENTERED.
