RESOLUTION NO. 121400-38

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF BEAVER IN THE COMMONWEALTH OF PENNSYLVANIA, IN ACCORDANCE WITH ORDINANCE NO. 051100-PK THE BOARD OF COMMISSIONERS HEREBY AUTHORIZES LIMITED ARCHERY HUNTING IN THREE (3) BEAVER COUNTY PARKS: (1) BRADY'S RUN PARK,

(2) BRUSH CREEK PARK AND (3) ECONOMY PARK;

Whereas, there is an overpopulation of deer in the Beaver County Parks that are over-browsing on the forest's undergrowth and there has been a conservative figure of one hundred fifty deer related accidents in or near the three (3) Beaver County Parks road systems causing an estimated \$450,000.00 worth of property damage in the year of 1999. There are an estimated number of 35,000 sportsman who would like to utilize the three (3) Beaver County Parks. It has been recommended by the Beaver County Brady's Run Lake Committee that archery hunting be allowed in the three (3) Beaver County Parks. The proposed dates for the archery hunting are:

Year = December 26, 2000, through January 13, 2001

All State Hunting Regulations will apply to the Archery Hunting in the Beaver County Parks.

Stipulations to the Archery Hunting in the Beaver County Parks are:

BRADY'S RUN PARK

- A. Hunting areas will be contiguous from:
 - 1. Wildwood Road (SR 04092)
 - 2. Anchortown Road (SR 04014)

No parking for the purpose of hunting will be permitted on

Brady's Run Road or park shelter areas.

No hunting will be permitted in the main use park areas, such as picnic areas, walking trails, etc. and so will be designated. No permanent tree stands will be permitted.

BRUSH CREEK PARK

- A. Hunting areas will be contiguous from:
 - 1. Barrisville Road (T-578)
 - 2. Petrie Road (T-613)

No parking for the purpose of hunting will be permitted on the main park road (road through park).

No hunting will be permitted from the park's main road area (road through park) and so will be designated. No permanent tree stands will be permitted.

ECONOMY PARK

- A. Hunting areas will be contiguous from:
 - 1. Legionville Hollow Road
 - 2. Hemmerle Road (LR 04114)

No parking for the purpose of hunting will be permitted on Forcey Drive.

No hunting will be permitted off of Forcey Drive.

No hunting will be permitted in any main park areas such as shelter areas, swimming pool area, etc. and so will be designated. No permanent tree stands will be permitted.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Beaver, a fourth class county under the laws of the Commonwealth of Pennsylvania, AND IT IS HEREBY RESOLVED:

 That, the Commissioners of Beaver County, as recommended by Beaver County Brady's Run Lake Committee, authorizes, in accordance with Ordinance No. 051100-PK, limited Archery Hunting in three (3) Beaver County Parks: (1) Brady's Run Park, (2) Brush Creek Park and (3) Economy Park, stipulations and regulations listed above.

- 2. That the Board of Commissioners, for and in behalf of the County of Beaver, is hereby authorized to execute five duplicate counterparts of said Agreement and the Chief Clerk of the County of Beaver is hereby directed to attest the due execution thereof and to affix the Seal of the County of Beaver thereto.
- 3. That, following the proper execution, attestation and ensealing of said duplicate counterparts of said Agreement, the Chief Clerk of the County of Beaver is hereby directed to cause delivery of the same as follows: The original to the Controller of the County of Beaver; one duplicate counterpart to the Beaver County Law Department; one duplicate counterpart to Joseph West, Director for the Beaver County Recreation Department; one for John Scherfel, Director of the Beaver County Conservation District, for proper distribution.
