 - Aviation Sciences Center – Grant Agreement signed and submitted to OB 12/23/2025 by Mr. Kochanowski.
 - Golden Dome Infrastructure – Entrance Conference on 1/12/2026. Mr. Joyce is working on Cooperation Agreements.

- Bet Tech Warehouse RACP - \$3.5million – Construction of roadway and warehouse building, including all utilities and other amenities on Woodlawn Road in Aliquippa. RDA's signed and submitted to LSSE. Application submitted by LSSE on 9/23/25.
