911 PROGRAM RECERTIFICATIONS

As a new requirement by the Pennsylvania Emergency Management Agency (PEMA), every 2 years our Quality Assurance (QA) and Improvement Program and Training Programs are required to be recertified. Funding for our 9-1-1 dispatch program is dependent upon our successful certification of the various 9-1-1 programs. The certification review is conducted by the PEMA 9-1-1 Office to verify that telecommunicator training and QA programs comply with the minimum requirements as adopted by PEMA.

I'm happy to say that both of those programs have been successfully recertified. This is a testament to the leadership of Deputy Director of 9-1-1 Brian Murray, the 9-1-1 administrative team and all of our employees!

Tina Martsolf is the 9-1-1 Quality Assurance Manager. She is required to review telecommunicator work performance and document compliance according to directives and standards. The QA process is also a way to identify learning opportunities and to reinforce good behaviors and incorporate best practices. Operation Managers Justin Magnifico and Chris Stone are instrumental in training and evaluating new employees as well as overseeing continuing education. 9-1-1 employees are required to have a certain amount of continuing education hours per year to maintain their certification.

The telecommunicator training program must comply with all training requirements adopted by the Commonwealth and includes curriculum for classroom, on-the-job, recertification, promotional, remedial, and continuing education. Special thanks to our 9-1-1 employees for doing their part to make this program successful.

In addition to our 911 program recertification, Beaver County's Hazmat Team 700 completed their 4-year recertification this summer as well. Jeff McKay has more details on the following page.

HAZMAT TEAM 700 RECERTIFICATION


Beaver County Hazardous Materials Response Team 700 has completed the recertification process, and the Pennsylvania Emergency Management Agency (PEMA) has certified Team 700 to continue to respond to hazardous materials incidents. Hazardous Material Response Team (HMRT) certifications are valid for a period of 4 years, and Team 700's certification expires August 31, 2027.

The team's simulated scenario for the recertification exercise was to respond to a transportation accident involving a vehicle carrying a 1 ton chlorine tank that was damaged and leaking. Patterson Township and Patterson Heights Fire Departments responded, assessed the scene and requested the Hazmat Team. Medic Rescue assisted in the pre and post medical monitoring of all responders, and Patterson FD also served as decontamination personnel for the Hazmat Team.

We had a great turnout of our Hazmat Team, and we thank you for your dedication to the team and the citizens of Beaver County. Once again, thank you to Medic Rescue and Patterson Fire Departments for participating, you did a great job.

RADIOLOGICAL PROGRAM UPDATE

As many reading this newsletter know, Beaver County has a nuclear power plant, Beaver Valley Power Station, within its borders, located in in Shippingport Borough.

What some may not know, is that by having a Nuclear Power Plant within the county, our community is required to complete numerous preparedness activities in case an emergency transpires. These requirements make counties with Nuclear Power Plants some of the best prepared areas in the country.

Preparedness is an ongoing effort. This year, so far, we have met with all of our transportation providers and given them training and information relative to their responsibilities. We have also offered and provided three Regional Fire Department training sessions throughout the county, have begun reviewing our emergency plans (a never ending task!) and have begun annual equipment calibrations and/or equipment replacement. This list is just a snap shot of the many items mandated by the radiological preparedness program.

We should mention that our next Beaver Valley Power Station Evaluated Exercise is scheduled for June 11, 2024. Any agency who is normally involved: please mark your calendar!

RADIO PROJECT UPDATE

Bearcom has been busy installing mobiles and dropping off portables to departments over the last few months. If your department hasn't been contacted, they should be reaching out to you in the near future. We have a few departments who haven't paid. If you haven't received your invoice or need to send it in, please contact the Beaver County Commissioner's Office.

We've also been asked by departments if we, as the county, are programming radios. At this time we are not programming radios, and we also ask that you refrain from programming your own radios. Programming can be problematic when not done correctly. Changes to one parameter may have an unintended effect on another function of the radio. Programming of radios must be maintained and conducted exclusively by your vendor. Users should also refrain from using modified accessories and antennas as they may have a negative effect on the radio's ability to perform to specs. We will be putting out a radio fact sheet in the near future explaining what features will be required in each radio.

We are also in the process of upgrading our current radio sites to be digital ready, and we are adding four additional sites to enhance the network. Once that is completed, we will have the ability of switching to digital. During this process, we will have to take sites down a few hours at a time to swap out equipment.
